

School Parent and Family Engagement Policy Caledonia Middle School

JOINTLY DEVELOPED

<u>Caledonia Middle School</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Developing the Policy:

SCHOOL-PARENT COMPACT

- v. Provide regular events that showcase student's learning and invite parents to participate.
- vi. Provide Parent and Family Engagement workshops at least 4 times a year.
- vii. Meetings for ESL parents with interpreters and materials available for checkout
- B.
